HELD: JUNE 13, 2018

Pursuant to due call and notice thereof, a regular meeting of the School Board of Southern Plains Education Cooperative, State of Minnesota, was duly held on June 13, 2018, at 5:00 o'clock p.m.

Member \_\_\_\_\_ introduced the following resolution and moved its adoption:

**RESOLUTION RELATING TO A LEASE PURCHASE FINANCING AND PROVIDING FOR SALE OF CERTIFICATES OF PARTICIPATION, SERIES 2018A**

BE IT RESOLVED by the School Board of Southern Plains Education Cooperative, State of Minnesota, as follows:

**1. Authorization.** The Board hereby finds and declares that it is necessary and expedient for Southern Plains Education Cooperative ("SPEC") to enter into a Ground Lease, a Lease Purchase Agreement and a Trust Agreement and to sell and issue its Certificates of Participation, Series 2018A Evidencing the Proportionate Interest of the Registered Owners thereof in Lease Payments to be made by SPEC pursuant to the Lease Purchase Agreement (the "Certificates") in the total aggregate principal amount of not to exceed \$11,000,000. The Certificates will be used to (i) finance the purchasing, remodeling, renovation and addition to a building and site located in Fairmont, Minnesota, which is centrally located to where students are serviced throughout SPEC and will house programs and services provided by SPEC to school districts; (ii) finance the purchase of fixtures, furniture and equipment for the building; and (iii) pay costs of issuance associated with the Certificates.

**2. Sale.** The Cooperative Board desires to proceed with the sale of the Certificates by direct negotiation to Dougherty & Co. (herein, "Dougherty"). Dougherty will purchase the Certificates in an arm's-length commercial transaction with SPEC.

**3. Approval of Sale of the Bonds.** The Business Manager and any Cooperative Board Officer are hereby authorized to approve the sale of the Certificates in an aggregate

principal amount of not to exceed \$11,000,000 and to execute a Certificate Purchase Agreement with Dougherty for the purchase of the Certificates, provided the True Interest Cost does not exceed 4.75%.

**4. Adoption of Approving Resolutions.** Upon approval of the sale of the Certificates by the Business Manager and any Cooperative Officer, the Cooperative Board will take action at its next regularly scheduled meeting thereafter to adopt the necessary approving resolution as prepared by the Cooperative's Bond Counsel.

**5. Official Statement.** SPRINGSTED Incorporated is authorized to prepare and distribute an Official Statement related to the sale of the Certificates.
