Concerning Teacher of the Deaf/Hard of Hearing Sharing  
Between  
River Bend Education District #6049  
And  
Southern Plains Education Cooperation #0915**

WHEREAS, River Bend Education District and Southern Plains Education Cooperative #0915 are in need of a Teacher of the Deaf/Hard of Hearing for the instructional program in their district.

IT IS, HEREBY, AGREED that starting August 26, 2019 and ending June 1, 2020 that Jacquilyn Shasky, Teacher of the Deaf/HH under employment contract with River Bend Education District, will spend .6 FTE of her contract time with Southern Plains Education Cooperative.

IT IS FURTHER AGREED that Southern Plains Education Cooperative will reimburse River Bend Education District \$59,246.00 for salary and benefits (Note: this is an estimate for FY 19-20. A final amount will be forwarded as soon as negotiations have been completed). Mileage will be reimbursed from the River Bend office in New Ulm to the service site(s) and back at the IRS mileage rate.

IT IS FURTHER UNDERSTOOD that River Bend Education District will bill Southern Plains Education Cooperative quarterly for services.
